- 1. Call to Order.
- 2. Approval of Agenda.
- 3. Approval of Minutes.
 - June 15, 2022 Approved.
 - July 18, 2022 Approved as amended Item 3 June 15, 2022 and addition of item to reflect the notice received from Parkland County that Robert Fernandez is no longer the County's representative on the Board.
- 4. Ongoing Business.
 - a. TransAlta
 - Highvale Mine Reclamation David Chanasyk will be returning to Alberta at the
 end of August and Stan is awaiting a response from TransAlta regarding the
 possible release of an Executive Summary of the Reclamation Plan submitted to
 AER at the end of June.
 - Sundance WTP it is anticipated that the Plant will be operational sometime in the next week subject to any issues with the boat launch construction.
 - Reclaimed Ash project no further information has been received.
 - b. Summer Water Sampling.
 - The August sampling has been completed and was attended by a number of municipal officials.
 - c. WWMC Education Outreach.
 - Neil reported on the AIS event at the Wabamun Boat Launch.
 - Neil also reported that on September 6th, a number of members of Municipal Councils in the watershed will meet with MLA Getson regarding possible Provincial support of a municipal sewage inspection project.
 - Randy will be coordinating a watershed information event on August 13th at the Provincial Park boat launch.
 - The Seba Beach Seniors' will be holding an event at their hall on August 17th.

d. Municipalities.

- Parkland County Whitewood Sands Riparian Restoration no additional information available at this time.
- Seba Beach Neil indicated that following the Septic Sense workshop the Village will be considering an inspection program of systems in the Village and the estimated the costs of such a program.

e. Reed Bed Restoration.

 Sue reported that a member of Michele Foster's firm will undertake a reed mapping project which could be completed in late August or early September.
